- Actively coordinate and work with on-site task supervisor in providing appropriate learning experiences for the interns.
- Attend an orientation session provided by the School (required for all new field educators).
- Provide the student with an orientation to the agency, including information on safety protocol, HIPAA requirements, or other regulations specific to field site.

**Duties and Responsibilities (Field Liaison):**

- Reviewing and providing input to students and field educators regarding the learning contract.
- Making a minimum of one field visit during the fall semester and one during the spring semester for each of the assigned students. The visits should include a three-way meeting with the student and field educator at the field placement site.
- Be available to problem-solve issues with the student and/or field educator via phone or through additional field visits as needed; document any significant problems and the recommendations made to address the problem.
- Reviewing the Field Performance Evaluation Form completed by the field educator at mid-placement and at the end of the student's placement.
