Within the School, the Sexual Health and Reproductive Equity (SHARE) Program is committed to conducting rigorous, community-engaged research to advance the understanding of what it takes for individuals to have the families they envision, to realize reproductive self-determination, and to experience healthy sexuality.

This position will support the California Abundant Birth Project (ABP) Evaluation study. ABP is a guaranteed income program for pregnant people with risk factors for preterm birth. Originally a pilot program in San Francisco, the California ABP will serve at least 725 pregnant people in 5 counties (Los Angeles, San Francisco, Contra Costa, Alameda, and Riverside). The California ABP Evaluation Study will focus on the subset of participants who identify as Black or African/American. The Evaluation will use community-based participatory research approaches to understand the impact of ABP on adverse pregnancy outcomes, stress, and mental health.

Responsibilities

- Responsible for gathering and analyzing research data; prepares and summarizes information and / or recommendations. Participates in data analysis. Coordinate recruitment, collaborate with community and research partners, Coordinate collaboration with research partners and external stakeholders. Utilizes existing resources and develops and conducts training materials. As needed, develops strategies to increase participant engagement and other activities to improve retention rates.
- Maintains and revises protocols and systems for recruitment, consent and tracking of study
 participants. Works with team to conduct human subjects research, including recruitment,
 consent and data collection. Specific tasks may include: Maintain tracking system for participant
 recruitment and consent; Recruit and consent participants; Assist with researching and resolving
 issues that may arise related to administrative regulations; using sound judgment and
 independent problem solving skills.
- Conducts comprehensive assessment of the recruitment environment including speaking with other research teams recruiting similar participants, recruitment site personnel and current study participants to determine where bottlenecks exist and propose an alternative recruitment protocol.
- Mentor and supervise students, community researchers, and/or volunteers.
- Coordinates and participates in research project planning and collaboration with ABP Evaluation project staff. Specific tasks may include: Support various forms of meeting coordination, event coordination, project calendar management, travel coordination and reimbursements, and high-

- Assist with IRB applications/amendments/renewals in the UC Berkeley Committee for Protection of Human Subjects online system.
- Collaborate with the Principal Investigator, oversees and executes writing with internal and external colleagues, publications, manuscripts, research reports, presentations, abstracts, or meeting summaries

- Commitment to and demonstrated experience working with Black communities. Demonstrated
 ability to work collaboratively with community stakeholders and partners, study participants and
 individuals with a wide range of racial, ethnic and educational backgrounds.
- Demonstrated experience collecting and analyzing social science data, including surveys and qualitative interviews.
- Ability to effectively manage multiple priorities, prioritize projects and meet the demands of a fastpaced and dynamic work environment. Adaptable to quickly changing priorities
- Ability to problem solve, troubleshoot, and use sound judgment in responding to issues and concerns.
- Active listening, critical thinking, multi-tasking and time management skills.
- Strong communication and interpersonal skills to communicate effectively, both verbally and in writing
- At least one year full-time experience working on social science or health research projects with human subjects
- Ability to take initiative and solve problems independently while understanding when to seek guidance from manager or others.
- Broad academic knowledge of or applied background in social science or health research with human subjects proven by successful planning, initiation, execution, and reporting of previous investigations
- Demonstrates ability to analyze, research and synthesize large amounts of data with strong attention to detail.
- Proficient in ability to multi-task with demanding timeframes.
