Approximately 65,000 visits occur annually including Primary Care, Urgent Care, Occupational Health and Specialty Clinics. Services are designed to minimize the impact of illness, emotional distress and injury on studies and work. informed, and person-centered assessments and interventions to address the immediate needs of the individuals and communities in crisis at UC Berkeley.

The CMCR team currently functions on a four-tens schedule, subject to change as needed for team/operational needs. This role supports full week coverage, with working hours among the team varying in the range of 12:00pm - 10:00pm. Ideally the Clinical Lead is available Sunday - Wednesday (days and/or hours may shift to meet organizational need).

Responsibilities

- As a clinical leader on the team, performs crisis assessment, intervention and evaluation, diagnosis, and psychotherapy including treatment of the most difficult and complex cases involving high risk (e.g. risk of harm to self or others). Will apply advanced knowledge to provide consultation to staff regarding clinical services including the management of complex, high-risk cases. May develop and deliver psychoeducation and other outreach programs, including crisis outreach, when needed.
- Under the supervision of the Assistant Director of Crisis Response, applies advanced concepts to coordinate the day-to-day operations of CMCR including, serves in a back-up capacity to the Assistant Director of Crisis Response, as needed.
- Develops and coordinates programs and projects regarding a range of issues such as access to
 culturally sensitive clinical services specific to crisis response. Assists with the development of
 clinical standards of care, policies, and procedures. Will serve on committees and attend
 meetings regarding the coordination of clinical services, crisis intervention, and support and
 program development. As an advanced clinician will provide consultation to staff regarding
 clinical services including the management of complex, high-risk cases.
- Trains clinical staff, Mobile Health Technician, and student staff (outreach and post-crisis peer support) regarding the delivery of crisis clinical services staff in a range of aspects of clinical service delivery. Provides clinical supervision of professional graduate-level trainees and associate-level clinicians.
- Serves on committees and attends meetings of significance to CMCR, SMH, and the University.
- Other duties as assigned.

- Commitment to multiculturally informed care models and experience working with a highly diverse community
- Advanced skills associated with problem-solving and critical-thinking.
- High degree of sophistication, knowledge, and willingness and/or experience managing complex and collaborative systems.
- Experience and skills associated with program development and implementation.
- Ability to work in a highly collaborative manner with diverse client groups, multidisciplinary mental health and medical staff, and faculty.
- Advanced verbal and written communication skills.
- Ability to adapt to using computers and tools employed by the team and UHS, with a strong understanding of electronic/medical records systems
- Advanced knowledge and understanding of clinical counseling principles, methods, procedures,
