### **Position Summary**

This role would conduct research on designing, recommending and evaluating policies for accelerating deployment of clean energy, mitigating and adapting to climate change in India and the global south. This would include deep understanding of policy landscape for resilience to extreme heat in India, quantitative methods to assess heat vulnerability as well as specialized geo-spatial assessments; various policy and regulatory levers that have resulted in cost declines for clean technologies; issues regarding scaling up deployment in energy sectors; best practices from leading markets such as U.S., Europe and China; current climate policy landscape and drivers for clean energy transformation globally.

The role involves conducting high-resolution spatial and quantitative analyses using tools like Google Earth Engine, ArcGIS, and Python to support climate adaptation and mitigation in India. It includes managing large geospatial datasets, contributing to policy research and writing, and translating technical findings for diverse stakeholders. The position supports implementation through collaboration with government agencies, NGOs, and research institutions, and involves active participation in stakeholder engagement. Additional responsibilities include assisting with fundraising and project management, mentoring interns and research assistants, and strengthening institutional knowledge through standardized workflows and internal training. Must have experience with energy/climate focused research and policy analysis, preferably in India.
