Job Description

The Department of Urban and Environmental Policy and Planning at Tufts University is searching for a part-time lecturer to teach one graduate-level course on Greenhouse Gas Management in Fall 2024. A syllabus for how the course has been taught recently is available upon request.

This course will introduce students to the fundamentals of greenhouse gas (GHG) accounting, including scopes frameworks, inventory approaches and protocols, reporting, forecasting, and target-setting. It will also explore best practices for GHG reduction/mitigation and tracking progress over time. Additional components of the course will consider emerging methods of Life Cycle Analysis, consumption-based accounting, and embodied carbon assessment. Importantly, students will reflect on limitations associated with current modeling, methodologies, and challenges of accounting for GHG emissions from local to national and global scales, and consider implications for policy and planning as
